



<b>Responsibilities:</b>	<p>Serve as Section Examining Committee Chair from July 1 - June 30.</p> <ul style="list-style-type: none"><li>• Encourage Section members with proper qualifications to advance in membership grade. Publish information on qualification requirements and the application process in the Section newsletter.</li><li>• Review application for advancement to the grade of Senior member. Provide recommendations for action to the Society's Examining Committee. Notify the applicant of advancement in grade after approval from the Society's Examining Committee has been received.</li><li>• Identify and contact potential candidates for advancement to the grade of Fellow. For those interested in advancement, work with them to develop the necessary information to determine whether they qualify for advancement.</li><li>• Obtain sponsorship of the application by at least five (5) or more Honorary, Fellow, or Senior members of the Society.</li><li>• Submit all Fellow applications and supporting documentation to the ASQ Society Examining Committee by July 15 of each calendar year. The Society Examining Committee will make final recommendations for approval to the Board of Directors to be voted on during the November meetings.</li></ul>
